### **Sheriff's Deputies to Attend "National Night Out Events"**

Shelby County Sheriff Mark H. Luttrell, Jr., members of his command staff and Deputies assigned to various Sheriff's Office bureaus will join hundreds of people throughout Shelby County tonight at "National Night Out" events.

**"We have found many of the safer neighborhoods in Shelby County are those that have active neighborhood associations. Citizens involved in neighborhood watch feel more accountable to their neighbors and are often the ones to report suspicious behavior to our Deputies,"** said Shelby County Sheriff Mark H. Luttrell, Jr.

Sheriff's Deputies have been invited to several community gatherings across Shelby County starting at 4 pm and continuing throughout the evening. The local neighborhood groups will join others across the country to promote community safety and the importance of neighbors working with law enforcement agencies to help prevent crime.

**"It is my hope National Night Out events will emphasize to citizens the important role they have to help keep Memphis and Shelby County as safe as possible. Our goal is to maintain routine contact with residents to keep them informed about crime trends in their neighborhood,"** added Sheriff Luttrell who will attend three events tonight:
